## **CHAIRMAN'S REPORT**

Members,

The composition of the 2015/2016 Board of Management changed significantly with Paul Hynes relocating to Deputy Chairman, Don Collins reverting back to Treasurer, Noel Hodges elected as Secretary, Jenny Moore continuing as Catering Director, Allan Cullen continuing as Gaming Director, Men's President Peter Hamilton and Men's Secretary Brian Bottrell and Ladies President Esther Cullen and Ladies Vice President Diane Pickett elected as Board members.

The Club Action Plan, Club Management, Operation and Board Committee member's responsibilities were reviewed and the club budget for the upcoming year was adopted. From the outset, the Board members displayed the confidence and initiative required to ensure the completion of the upgrading of our club facilities and equipment that would see our club well positioned to tackle the changing Burleigh demographic of increased dining, liquor and gaming outlets.

Despite a difficult trading year and substantial spending to effectively advertise our club functions, replace outdated club equipment and finish the remaining club upgrades, the club can confidently move forward. However, it behoves on our bowling and social members to financially support the club.

As outlined at the 2015 AGM, the Board of Management has delivered on its promises to give back more to our bowlers which included:

- substantial increases to the social bowler's prize money for both our members and visitors,
- increasing our club pennant car travelling allowances,
- maintaining the club championship bowls prize money at the current level,
- paying for interclub competition nomination fees,
- sponsor our interclub competition bowlers to help cover their travel and accommodation costs,
- sponsorship of our club bowlers selected in Queensland and Australian teams,
- maintaining our full membership fees at the current level,
- maintaining the free tea, coffee, sugar, milk, biscuits and peanuts for all our bowlers,
- retaining our club member discounts and birthday drinks,
- paying GCTDBA umpire and coaching course fees, and providing post club competition finals team drinks.

The continued loss of bar trade on bowling days coupled with the cost of providing our bowlers with free tea, coffee, sugar, milk, biscuits and bar snacks in the form of peanuts from the bar, plus the ongoing loss from our coffee machine and the substantial cost of maintaining our greens and surrounds, the Board of Management can no longer ignore these matters.

With this in mind, the Board of Management has increased the mat fees by \$1 to \$8 and increased the cost of beverages from our coffee machine from \$1 to \$2 with effect from 1<sup>st</sup> January 2017.

In the past year, 2015/2016, the combined income from our two Bowls Sections was \$230,590 less expenses of \$230,500 resulting in a net return of \$90. When the \$143,000 cost of maintaining our greens and surrounds is considered, a real deficit of \$142,910 is realised.

The estimated income from the increased mat fees in 2017 will be \$18,000 (based on the same number of bowlers as the past year) coupled with the estimated savings of \$46,000 for the employment of our green keepers and the maintenance of our greens and surrounds, the deficit will be reduced by \$64,000 to a manageable \$79,000. These actions taken by the Board of Management will ensure the continuance of the bowler benefits, listed above, for the foreseeable future.

The \$1 increase for beverages from our coffee machine will eliminate this deficit of \$420 and produce a net return of \$2,700.

During the year several important actions were undertaken and achieved:

- The club constitution was significantly amended, subsequently adopted by the members and registered by Queensland Business Services. Many thanks must go to the excellent ongoing legal support we receive from our honorary solicitor, Ian Kennedy, through McLaughlins Lawyers.

- Unbeknown to the Board, our Club Building Classification, since 1998, has been incorrect. The Classification 6 Retail instead of Classification 9B Club Assembly Building substantially reduced our permissible Club Occupancy Limit and severely limited our Club Building and Fire Insurance cover. In conjunction with a competent Building Certifier the club extensions and greens shed now have GCCC approved final inspections and the Club is now certified as a Classification 9B Club Assembly Building with an internal occupancy limit of 500 persons.
- The Gaming lounge update has been completed with the purchase of 7 new gaming machines and 3 gaming machine upgrades at a cost of \$180,000. Further costs are envisaged in the future for our gaming and adding machines due to the introduction of the new \$5 notes, to be followed annually by the \$10 then the \$20, \$50 and \$100 notes.
- Recent changes to the 'Tobacco Laws in Queensland resulted in the Board reviewing and updating our existing Smoking Management Plan from 1<sup>st</sup> October 2016 and implementing our revised club 'Designated Outdoor Smoking Areas' in order to comply with Government legislation and the wishes of the vast majority of our non-smoking members.
- Card-IT has been implemented at considerable ongoing costs for our gaming and bar patrons, who are now able to impress cash on to their individual membership cards and earn transaction bonus points, redeemable at the bar.
- EFTPOS has been introduced into reception, the bar and the bistro enabling our patrons to pay by cash or EFTPOS.
- Circumstances resulted in Trevor Crompton being appointed and employed mid year as the Green Keeper along with Vince Sullivan and Keith Murphy as Assistant Green Keepers. Trevor, Vince and Keith are to be congratulated on the manner in which they have embraced these responsibilities and the improvement, standard and appearance of our greens and surrounds including our external bowling equipment – well done.
- The introduction of the National Broadband Network (NBN) necessitated the replacement of our existing club phones and the updating of our security system.
- The out dated club Multi-Screen System had to be replaced due to the failure of the mother board.

The entertainment committee ably led by Paul Hynes has worked tirelessly throughout the year to provide consistent high quality entertainment. We are continuing to increase our club patronage and will continue to provide top class shows, regular themed Saturday night entertainment commencing in January 2017, weekly trivia and of course our Wednesday and Friday night membership draws and great raffles.

To our Bowling Presidents, Peter Hamilton and Esther Cullen and their respective Council Committee members, thank you for the excellent ongoing management of our bowling affairs. Peter Hamilton is stepping down as a requirement of our constitution after 5 years as the Men's President and on behalf of the Board of Management and club members, I thank Peter for his considerable input to the Board and the streamlining of the operations of the Men's bowling section.

Our Bistro Caterer Steve Paul, since taking up the position as club caterer in July 2015, has produced extensive menus and provided our members and guests with excellent restaurant standard meals at very reasonable prices – well done.

Thanks also to Don Bode for maintaining and repairing our club, plant and equipment, the Camels for their ongoing recruitment of new bowlers and support of the club, the club coaches, Ron Alexander and Noel Hodges for the induction and coaching of our new bowlers, our Umpires who step up to the task when required, our barefoot bowling attendants, our club cleaners Gary Pearson and John McGovern, and most importantly, the volunteers especially those that clear our gaming machines, conduct our weekly raffles, man our games office, assist the green keepers and carry out the many other unseen tasks – thank you.

Finally, on behalf of all the Board members I offer a sincere thankyou to our Club Administration Manager Karen Gilfillan, our Bar Manager Garry Potts and their respective staff members for their exceptional devotion to their duties.

Our club staff have, by their warm receptive attitude, ensured that the members and visitors to this club have been treated with respect and indeed as friends. Well done – you are our greatest asset.

Our club can not and does not compete with our nearest competitor by offering substantial promotions, instead we continue to provide outstanding customer service, put on great shows, serve fine food and beverages and so enhance our reputation as the 'place to be in Burleigh'.

2015 and 2016 have been all about renovating, upgrading and putting a club maintenance program in place. This has been achieved, be it at substantial cost and effort, and as a direct result the club can now compete, I believe, successfully against our local growing number of competitors.

Moving forward, the Board of Management’s primary objective for 2017 is to increase our financial reserves.

Thank you to all the members of the board and well done on another successful year.

**TREASURERS REPORT**

It is my privilege, on behalf of our Board, to present: -

1. Our Balance Sheet
2. Our Financial Statements setting out our income and our expenditure.
3. Our Audit Report.

**Balance Sheet**

Our balance sheet is set out on Pages 18 and 19 and sets out the current worth of our Club. The first item of interest is of course our Cash Assets. This sets out our bank account balances, plus our term deposits and our floating cash on hand to total \$1,075,968. As set out in a previous Annual Report, do not all rush out and spend the lot. It is not all ours to spend. This amount provides for our trading account, our gaming account, our bar, ATM, Keno floating cash, office pretty cash, statutory/voluntary reserves and leaves \$720,000 as our accumulated cash reserves. Adequate / inadequate is a matter of individual opinion, but we do have solid financial backing. Not as good as last year, but still significant.

**Our Liabilities**

Set out on Page 19. We have no ‘new’ liabilities, other than the “Card It System” but our ‘old faithfuls’ are still with us and have been up-dated to take into consideration the current situation. You will look in vain for any outstanding balances for any loans, mortgages or overdrafts. We have none. We are completely free of all debt.

**Income and Expenditure**

This year our total income amounted to \$2,579,479 compared to \$2,653,923 last year. A decrease of \$74,444.

Our total expenditure amounted to \$2,642,473 compared to \$2,508,808 last year. An increase of \$133,665.

Our operating Net operating Profit this year of \$97,942 (see page 17) compares to \$258,650 last year. A decrease of \$160,708 attributed to recent increased competition in our area affecting our income and increased expenses in our day to day operations.

Our Audited Accounts are set out on pages 15 to 27 and set out our financial operations in full and complete detail.

The following comment is offered in regard to various sections of our Club.

The above Table sets out the adverse results incurred by our main Trading activities: Gaming, Bar and Keno, as a result of the additional Social Club competition in our area. In addition, our Operating Costs increased in regard to Advertising, Gaming Pay-out, L.S.L., Trivia Promotion, Levies/Capitation, Security, Computer software, Wages, Superannuation, Live Music, Insurance, Members Entertainment. In all a fairly difficult year. Other results were affected by:

**Mens**

Decrease in Green Fees, decrease in Merchandise sales, Increase in Summer Nines Pennants (two teams), increase in Trophy pay-outs (Board decision).

**Interest Rates**

Current interest rates offer a poor return on our Term Deposits. Reduced

**Capital Works**

In a situation where our expenditure on Capital Works exceeds our Net Profit, our accumulated Cash Reserves are reduced correspondingly, this has happened, with expenditure this year, \$187, 106.51 (incl. GST) on:

**(iii) Audit Report**

Our Audit Report is set out, in full, on Pages 13 to 27. The report contains no adverse comment and confirms the high standard and the accuracy in our Accounts as a result of the work of our Administration Manager.

**Prospects**

In view of the current operating conditions in our area, it would seem that to maintain our present level of operations, and work for an increased return from our club social activities, would indicate a Net Profit for next year in the vicinity of \$110, 000.

To Karen, our Administration Manager, Garry our Bar Manager, Steve our Caterer and to all staff thank you for your contribution to our club. I cannot forget Garry Pearson assisted by John McGovern, who are doing a fantastic job keeping our club looking spotless.

Several initiatives have been introduced over the last 2 years, including, extended club opening hours, juke box music, Wi-Fi internet access, redeveloped web site and Facebook page, electronic mail outs via email, radio advertising on Gold FM and 4CRB, meal deals and promotions, EFTPOS facilities at the bar and reception, fully booked out quality shows, customer and member surveys, loyalty points, and the introduction of the card-it system for poker machines.

Change within the community constantly happens. We are seeing that now with the emergence of Burleigh Beach as one of the most sought after tourist destinations on the coast. This club is in a prime position to capitalise on this, therefore we should pull out all stops to attract people to our club. Our monies to run the club come substantially from the bar and gaming income.

To keep abreast of legal requirements it has also been necessary to re-define smoking areas and change the way we perform the meat raffles. I trust members understand that heavy fines can be imposed for non-compliance with legislative requirements.

Unfortunately, it has been necessary to pass on the two liquor excise increases this year. The board was hoping to only pass on the one, however bar sales are flat, wages have increased in line with CPI and freight charges have also increased. The board has the responsibility of maintaining our cash reserves.

Despite a tough trading year our club is doing well. Ongoing initiatives will need to be implemented to keep our club competitive and at the forefront as a 'great place to meet and mingle'. I hope you continue to enjoy our club. Next year we will celebrate our 80<sup>th</sup> year and I am sure the 2017 Board will have some exciting functions in store.

## **GAMING REPORT FOR 2016**

Summary:

For the year ending 30th September 2016 the gaming operations of our club has turned over a gross income of \$768,388.45 down by \$74,187.79 on year 2015. This realized a net gaming profit of \$481,653.76.

It has been a difficult year for many clubs in the area, with growing competition and a mid-year election. I feel that this report, when read in conjunction with the treasures report, (ref. Club assets and gaming expenditure) that we have had a satisfactory result.

The purchase of the new multi denomination gaming machines, the repositioning of some of our other machines and the introduction of card-it has created a more inviting atmosphere which will hopefully improve our gaming operations for the upcoming year. The additional spending in our gaming area was required to keep the club competitive with in the locality. This was able to be achieved only because of the strong financial position the club has been in over the last several years.

I would personally like to thank all the volunteer clearance team members who continue to do a great job, with a special thanks to our computer man Rex , Don, Paul , Garry Potts and the bar staff and our club administration manager Karen and her staff for their ongoing support and guidance.

Due to the new Australian monetary notes an ongoing update program is required so the club can look forward to a satisfactory gaming trading year in 2017.

**Note 7: Summary of Significant Accounting Policies**

The financial report is a general purpose financial report prepared in order to satisfy the financial reporting requirements of the *Associations Incorporations Act*. The committee has determined that the association is not a reporting entity.

The report has been prepared in accordance with the requirements of the *Associations Incorporation Act* and the following Australian Accounting Standards:

AASB 112:	Income Taxes
AASB 1031:	Materiality
AASB 110:	Events after the Balance Sheet date
AASB 117:	Leases

No other Australian Accounting Standards, Urgent Issues Group Interpretations or other authoritative pronouncements of the Australian Accounting Standards Board have been applied.

The financial report has been prepared on an accruals basis and is based on historic costs and does not take into account changing money values, or except where specifically stated, current valuations of non-current assets.

The following specific accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report:

**(a) Income Tax**

The Burleigh Heads Bowls Club Inc. does not incur a liability for income tax due to an exemption under the *Income Tax Act*.

**(b) Inventories**

Inventories are measured at the lower of the cost and net realisable value.

**(c) Property, Plant and Equipment**

Property, plant and equipment are brought to account at cost or at independent or executive's valuation, less where applicable, any accumulated depreciation or amortisation. The carrying amount of property, plant and equipment is reviewed annually by the Board to ensure it is not in excess of the recoverable amount from those assets. The recoverable amount is assessed on the basis of the expected net cash flows, which will be received from the assets employment and subsequent disposal. The expected net cash flows have not been discounted to present values in determining recoverable amounts.

The depreciation rates used for each class of assets are:

**(d) Leases**

Leases of fixed assets, where substantially all the risk and benefits incidental to the ownership of the asset, but not the legal ownership, are transferred to the entities within the economic entity are classified as finance leases.

Finance leases are capitalised, recording an asset and a liability equal to the present value of the minimum lease payments, including any guaranteed residual valued. Leased assets are amortised on a straight line basis over their estimated useful lives where it is likely that the Burleigh Heads Bowls Club Inc. will obtain ownership of the asset or over the term of the lease. Lease payments are allocated between the reduction of the lease liability and the lease interest expense for the period.

Lease incentives received under operating leases are recognised as a liability. Lease payments received reduced the liability.

Leases of PPE, where substantially all the risks and benefits incidental to the ownership of the asset, but not the legal ownership, are transferred to the association, are classified as finance leases.

**(e) Employee Entitlements**

Provision is made for the entity's liability for employee entitlements arising from services rendered by employees to balance date. Employee entitlements expected to be paid later than one year have been measured at the present value of the estimated future cash outflows to be made for those entitlements.

Contributions are made by the Burleigh Heads Bowls Club Inc. to employee's superannuation funds and are charged as expenses when incurred.

## **MENS PRESIDENT'S REPORT – 2016**

Another terrific year at Burleigh Heads B.C. has come and gone.

Super Challenge results this year were not as good as in previous years. We were competitive but not up to our high standards of previous years. It was great to see the large number of supporters for our teams at home games. Full credit goes to all players who gave their all for our club.

The change in green keeping staff early in the year has produced positive changes on and around the greens. I would like to thank Trevor and Vince for their dedication in producing the best greens possible. Our club was again very busy during the winter months with our southern visitors joining us. The help received from the volunteers when greens maintenance times come round is also greatly appreciated.

Thank you to my fellow council members, Bruce McGregor, Brian Bottrell, Vince Sullivan, Bob Marin, Jim Wadling and Barry Senhenn. Without their support my role would be very difficult.

Special thanks to Bruce McGregor for his work organising the Wednesday and Friday night raffles and the Saturday raffle. Bruce had a great team of helpers, Steve and Gail McGaveston, Jim Wadling, Barry Senhenn, Peter Kerrigan, John Hughes and Ray Kennedy, if I have missed anyone I apologise.

With Vince Sullivan working on the greens he was required to resign from the men's council as per the club constitution. Vince took on the role of games office coordinator and has done a fantastic job organising bowls day workers for the games office, social bowls, championship games and integrating super challenge and pennants. It is not until people spend some time in the games office that they realise how much work is involved. Vince has managed to recruit a good group of assistants and although some spend more time in the games office than others, I thank every one of them for their support and their contribution.

We again noticed a slight decline in the number of winter visitors from past years. I have said for some time that as bowls numbers decline nationally so will the number of bowlers who travel north for the winter. We have no control over that situation. What we can do is make Burleigh the place where they want to play bowls. I believe we are succeeding with that objective by providing quality bowls as loan bowls, allowing them to hire lockers short term (when available), keeping our fees at a modest price and most of all and more importantly, making them feel welcome. Quite a number of our visitors thanked me for our hospitality before they went home, all telling me they will be back next year.

Our overall bowling numbers are up on last year. At the time of writing this report we have only lost 5 bowling sessions (we run 5 sessions per week) for the year. In the same period last year we lost 21 the year before we lost 8.

The Match Committee, Vince Sullivan (Chairman), Bob Marin, Jim Wadling and Barry Senhenn have again produced another smoothly run and well organised Club Championship schedule. Thank you for your commitment and your support. Coordinating this schedule is becoming harder when you have to work around issues such as super challenge, district events, state and national events and Sunday pennant games. All of which vary their schedules from year to year.

Last year I said I was disappointed with our singles championships in regard to markers. Too often players arrived to play and ask Vince if he can get someone to mark their game. It is the responsibility of the players to organise a marker. If you are not prepared to mark when beaten then don't enter.

Players and markers were also arriving out of uniform. It is important to remember that the dress code for markers is the same as for the players. This year we introduced a rule whereby if the marker is not in uniform then you play the game without a marker. If you choose to play with a marker out of uniform you will both be forfeited.

To our selectors Vince Sullivan, Graham Absalom, Steve Miller, Bob Mullens and Grant Fehlberg, I say thank you for taking on the unenviable task of selecting teams to represent the Club.

After the printing of last year's report Div. 2 went to Pine Rivers for the SE Qld playoff. They did us proud finishing 3<sup>rd</sup>.

It was a great result for Div 5. Whilst finishing 2<sup>nd</sup> in the district competition Burleigh was asked to take the place of a club that had withdrawn from the SE Qld playoff and won the event much to the disgust of the club that beat them in the district final.

This year we again fielded 6 teams in pennants. We had 3 teams make the playoffs. Divisions 2, 4 & 5. Division 5 won the flag and are now off to the SE Qld playoff. We wish them well.

The Burleigh Classic was once again a great success. Special thanks to Jack Matthews and Bob Marin for their coordination of the event. With the state government abolishing the long weekend in June we changed the format for the classic to cater for the workers. The change proved successful but may require some adjustments next year. The weather gods were not very kind to us. For the first time we lost a complete day due to torrential rain. Thankyou to Margaret McGregor and her team of Ladies for providing the morning teas.

This year we decided to have a greater involvement with the Australian Open with our club being used for 4 days. Jim Wadling took on the role of coordinator for our club and did a fantastic and professional job for us.

President's Day and Presentation Day was another successful day. It is great to see so many members on hand to acknowledge our championship award winners.
