#### **CHAIRMAN'S REPORT**

In the position of Deputy Chairman at the beginning of the year, I did not expect to be writing the Chairman's report in the club's 80<sup>th</sup> anniversary year. As a result of the resignation of Ray Fellenberg, and with the support of the board, I undertook the Chairman's position. It would be remiss not to mention the contribution Ray has made to our club and many members are saddened by his departure. Thank you Ray for your untiring work. Also to Karen Gilfillan who also departed during the year, thank you for 11 years of loyal service. To Allan Cullen who stepped into the deputy chairman and house director role and to Don Collins for assisting Allan in the gaming portfolio, thank you also.

To fellow board members, Don Collins, Peter Johnson, Allan Cullen, Bruce McGregor, Brian Bottrell, Di Pickett, June O'Dea and Jenny Moore, it has been a pleasure working in such a positive environment. To section Presidents Bruce and Di, your section members can be fully confident you represented them in the most professional manner and always putting the club first.

The current board members and I have been aware for some time that board members, by necessity, had become too involved in the day to day management of the club. This is not a criticism but clearly a line of management was missing across our club organisation. This aspect was verified by the release of recommendations by a Human Resource Consulting company engaged to undertake a functional assessment of our club operations. As a result of the recommendations a club Secretary Manager was appointed to manage and lead the day to day functions within the club. In a short period of time Justin O'Donnell has excelled in introducing a new enthusiasm and a greater sense of direction in club hospitality and management. Initiatives to increase club patronage and cost saving measures will be continually introduced.

Whilst 2015 and 2016 were all about renovating and upgrading, The Board of Management primary objective at the start of 2017 was to increase our financial reserves with the Treasurer projecting a net profit around \$110,000. Our financial report indicates we were short of that goal. Further explanation of our financial results can be found in the Treasurer report. However, the following facts require explanation:

Greens Maintenance & Wages. As a result of past book-keeping practices wages and materials associated with both the greens, and greens surrounds were being recorded against Greens expenditure items. This has had the effect of inflating the real cost of maintaining greens this financial year as work and material associated with concreting the bank on the northern side of green 1, in addition to substantial costs of shade post replacement, soil testing, spear pump replacement, rink numbering, scoreboards, equipment repair and many other sundry expenses were expensed against the greens. The book-keeping process has been amended. Much is being said about the condition of our greens. The same story has been heard for some years now. I make no apologies by saying, our present Greenkeeper inherited significant problems, borne out by independent soil tests after taking the job on. The lack of rain during the last growing season was a further setback. I have every confidence that Trevor, Vince and Keith will restore the greens to pristine condition, if the elements are on their side. Please encourage their work.

<u>Advertising</u>. The increase in expenditure was a direct result of an increased focus on promoting our club against the many other social venues in our area. Our shows, particularly the Rock & Roll Saturday nights have been well patronised by locals and visitors and have put the club forward as a great place for quality entertainment. It is a little disappointing that more members do not support our entertainment nights. Let the Board know the type of entertainment you would support.

<u>Catering</u>. There is no doubt a successful Bistro is crucial for the club. As a consequence of the contract caterer deciding not to renew his contract, the club will now be running the bistro by the employment of a Head Chef, reporting to the Secretary/Manager. The Board of Management has discussed the advantages and financial aspects of this change and is confident that it is the correct move. The club wishes Steve Paul all the best for the future.

Rather than looking back, the future should be the important focus. In maintaining the benefits members enjoy, to name a few, low subscription and mat fees in comparison to other clubs, generous social bowlers prize money, club members discount and birthday drinks, interclub car travelling allowances, maintaining club championship prize money, free tea, coffee, peanuts etc, it is necessary to operate our clubhouse at hospitality best practice to achieve maximum profit. Bowler benefits can only be maintained if sufficient revenue is being received. Right now, we could cut expenditure by earlier closing of the club, reducing staff levels, reduce or eliminate live entertainment, cut advertising, reduce prize money, etc, but I am sure most members would not wish all of the above to happen. As stated, the future board will need to grow our revenue stream through increasing membership and increasing visitor numbers to our club in addition to finding other revenue streams. In August I attended a 'future of bowls forum' hosted by Bowls Australia. Messages from both the President and the CEO indicated the whole industry of sport was under pressure. Bowls Club membership is declining all over the world. The goal must be more people playing bowls with good social programs in place. Bowls Australia further indicated those clubs that are performing are doing so by changing from traditional methods to more innovative methods such as changing game formats, relaxing dress rules to attract younger people, increasing social participation in the sport by barefoot and corporate bowls days, utilising social media to attract more bowlers and visitors to their club and increasing the clubs social activities.

We are well placed to achieve all of the above if our future strategy includes:

- Well positioned advertising and promotion of our facilities
- Effective use of social media tools for promotion
- Setting of realistic budgets and sticking to them
- Attracting sponsorship. (A challenge when businesses are also reigning in expenditure and increasing their use of social media advertising)
- A structured process in securing available grants
- Strong and visionary Men's and Ladies Committees
- Excellent playing greens
- Retainment and recruitment of bowlers
- Supporting the Camels as a recruitment source of new bowlers
- Promoting Barefoot and Corporate bowls
- Reviewing members draws /poker machine promotions /raffles, to attract more patronage
- Modern looking and comfortable clubhouse facilities
- Excellent Bistro meals at the right price
- Switched on staff who work as a team and go the extra mile
- Positive members who are seen to enjoy our facilities and welcome visitors
- Quality and consistent entertainment that brings people back

The following area deserves particular mention.

Membership Fees. Fees have increased to keep abreast of the Bowls Australia fixed affiliation fee increase of 3% annually introduced in 2015 and based on our 2015/2016 membership levels. Affiliation fees by Bowls QLD and the GCTDBA bodies have also increased, however at the time of writing the increases are unconfirmed. We are mindful of the extra burden of parking fees for the bulk of our membership and our fees remain more than competitive with neighbouring clubs.

Congratulations to all bowlers selected to represent our club in inter club events. I know you all gave of your best. Also to Club Championship winners, well done.

To the reception staff Brigitte and Keira, bar manager Garry and staff, barefoot bowls co-ordinators, the many volunteers who sell raffle tickets, staff our games office, contribute to the ladies trading table, and the many other unseen tasks, thank you. Our maintenance man Don Bode, umpires, coaches also deserve a special commendation. A special mention to the gaming machine clearance teams. Due to the retirement of some members and a lack of volunteers to take their place for this function the clearances will now be undertaken by bar staff. Well done to the volunteers for many years of getting up before dawn and helping the club.

Our club was showcased in the best possible way during our 80<sup>th</sup> birthday celebrations in September. Nothing but positive comments have been received and I thank you the members, and our wonderful staff for making this possible.

There is every reason to feel confident that next year will be a more positive one for our finances providing major unplanned maintenance work is not incurred.

Good bowling to all and I trust you all enjoy the friendship and ambience our club provides. The club, "at the centre of the community".

#### TREASURERS REPORT

It is my privilege to present on behalf of the Board our Balance sheet and Financial Statements for the year. However, there is not much pleasure to have to report that we could only manage a Net Profit of \$15,386.50 for the year. \$82,556 less than last year, \$243,263 less than 2 years ago. Not a successful year.

When members assess this result it needs to be taken into consideration that this amount falls far short of the actual requirements to sustain a Capital Works programme to ensure the longevity of our fixed assets and the efficiency of their fittinge, fixtures and ancillary equipment and the performance of our computer systems, cash registers, air con, our greens, and machinery, and gaming machines. A conservative estimate to meet this requirement is \$150,000 p.a. Apart from the desirability of a contribution to our Accumulated Cash Reserve to have funding readily available for future major club improvements.

The full details of our Balance Sheet are contained on Pages 18 & 19 of this report. Our Income and expenditure details are on Pages 15-24 (incl) and the Auditors Notes are contained on Pages 25-27 (incl).

<u>Balance Sheet.</u> Our Assets and Liabilities are set out in full detail, the main interest, or course, is our financial standing. Out total cash as at 30/09/2017 amounted to \$1,061,164 and after providing for our statutory and voluntary reserves, our working capital, cash floats there remains \$700,000 which represents our Accumulated Cash Reserve, compared to \$720,000 at the same time last year. We still have a substantial cash reserve with no out-standing loan/mortgage commitments. Our liabilities all have been updated to take into consideration the current situation. We have no "new" liabilities.

Income and Expenditure. Refer to Pages 15-17. our Trading Income for the year of \$1,020,010.74 Barely covers our Expenditure of \$1,004,624.24 leaving a Net Profit of \$15,386.50 As set out above. Why the decline? Our club has for the last 19 months, encountered severe opposition and competition from several Gaming, Liquor and Food outlets in our immediate locality, all competing for the same proverbial "Disposable Dollar". We have not coped very well with these changing conditions and adapted our methods of operation to cope.

Our income fell short of the Budget in regard to: Bar Sales, Raffles, Gaming, Keno, and Sponsorship.

Our Expenditure reduction occurred mainly in regard to reduced Gaming Cheques pay out of by \$116,292 off set by increases due to Relief Staff, Audit, Advertising, Electricity, Gaming Points System, Insurance, Professional Fees, Council Rates and Wages.

Barefoot Bowlers showed increases Ladies and Mens Sections both returned a Net Profit, however, our statistics prove that our club can not survive on Bowls alone . We need to increase our Income from other activities.

<u>Future Prospects.</u> To continue with "more of the same" is no longer profitable and therefore not an option. In our current situation, we have to trade our way out of the present unsatisfactory situation. Changes need to be made to increase our Income, reduce our Expenditure and restore our profitability to that applying as recently as 2 years ago, let alone 10 years ago when our Net Profit was \$380,000 p.a.

It is with this situation in mind that the Board appointed a Secretary/Manager with vast experience in Club and Hospitality operation, a necessity in order to improve our "bottom line". It has been noted that an increase of 3% in our Income and a 3% reduction in our Expenses in the year ahead would produce a Net Profit of \$155,000. the minimum necessary to sustain our Club and has been the basis on which to complete next years Budget.

The club has been responsible for organizing many great shows with the full house sign up on several occasions and a lot of this has to do with our courteous front office staff and our competent bar staff. Congratulations to you all.

Significant contributors to the bar trading in the coming year will be the continued bare foot bowls program, and more daily entertainment, like the big fight day and the football finals.

Our 80th anniversary celebrations were a great advert for the club. Saturday started with 100 bowlers having an all day 5 a-side tournament with a Neil Diamond tribute show in the evening. Sunday the club held the more formal side of the anniversary with entertainment with several official guests, men's and ladies patrons, life members and members attended. All had a marvellous time.

The club will continue to remain focused on maintaining customer service and consistency across all areas of operation for the coming years.

I would like to thank the members for their continued support.

#### Summary:

For the year ending 30th September 2017 the gaming operations of our club has turned over a gross income of \$758,405 down slightly by \$9,983 on year 2016. This realized a net 51.5% Gaming Profit of \$468,722.

It has been another difficult year to raise a dollar with growing competition in the area.

This report, when read in conjunction with the Treasurers Report (Ref Club Assets and Gaming Expenditure) I feel we have achieved a positive result.

The purchase of the new multi denomination gaming machine, our Card-It system is working better with players adapting well to the technology and new increased gaming cash payout figures will hopefully improve our gaming operations for the up coming year. The club must continue in its additional spending in our gaming area to keep the club competitive within the locality.

This is the last year the machines will be cleared by volunteers and I would personally like to thank all the Volunteer Clearance Team members. Some of our team have given 15 years service and a lot of us have been at the job for 11 years. All have done a great job. A special thanks to our Club Administration staff for their on going support and guidance.

#### **Note 7: Summary of Significant Accounting Policies**

The financial report is a general purpose financial report prepared in order to satisfy the financial reporting requirements of the *Associations Incorporations Act*. The committee has determined that the association is not a reporting entity. The report has been prepared in accordance with the requirements of the *Associations Incorporation Act* and the following Australian Accounting Standards:

AASB 112: Income Taxes AASB 1031: Materiality

AASB 110: Events after the Balance Sheet date

AASB 117: Leases

No other Australian Accounting Standards, Urgent Issues Group Interpretations or other authoritative pronouncements of the Australian Accounting Standards Board have been applied.

The financial report has been prepared on an accruals basis and is based on historic costs and does not take into account changing money values, or except where specifically stated, current valuations of non-current assets.

The following specific accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report:

#### (a) Income Tax

The Burleigh Heads Bowls Club Inc. does not incur a liability for income tax due to an exemption under the *Income Tax Act*.

#### (b) Inventories

Inventories are measured at the lower of the cost and net realisable value.

#### (c) Property, Plant and Equipment

Property, plant and equipment are brought to account at cost or at independent or executive's valuation, less where applicable, any accumulated depreciation or amortisation. The carrying amount of property, plant and equipment is reviewed annually by the Board to ensure it is not in excess of the recoverable amount from those assets. The recoverable amount is assessed on the basis of the expected net cash flows, which will be received from the assets employment and subsequent disposal. The expected net cash flows have not been discounted to present values in determining recoverable amounts.

#### (d) Leases

Leases of fixed assets, where substantially all the risk and benefits incidental to the ownership of the asset, but not the legal ownership, are transferred to the entities within the economic entity are classified as finance leases.

Finance leases are capitalised, recording an asset and a liability equal to the present value of the minimum lease payments, including any guaranteed residual valued. Leased assets are amortised on a straight line basis over their estimated useful lives where it is likely that the Burleigh Heads Bowls Club Inc. will obtain ownership of the asset or over the term of the lease. Lease payments are allocated between the reduction of the lease liability and the lease interest expense for the period.

Lease incentives received under operating leases are recognised as a liability. Lease payments received reduced the liability.

Leases of PPE, where substantially all the risks and benefits incidental to the ownership of the asset, but not the legal ownership, are transferred to the association, are classified as finance leases.

#### (e) Employee Entitlements

Provision is made for the entity's liability for employee entitlements arising from services rendered by employees to balance date. Employee entitlements expected to be paid later than one year have been measured at the present value of the estimated future cash outflows to be made for those entitlements.

Contributions are made by the Burleigh Heads Bowls Club Inc. to employee's superannuation funds and are charged as expenses when incurred.
